

CONDITIONS OF TICKETING AND ENTRY

PATRONS, PLEASE NOTE THE FOLLOWING CONDITIONS OF OUR ENTRY TO THE RACECOURSE.

1 RACE DAY TICKETING

- 1.1 All individuals entering the racecourse must possess a valid ticket or pass for the respective event.
- 1.2 Tickets are non-transferrable and non-refundable, except as set out in condition 3.
- 1.3 If a race meeting is cancelled or rescheduled prior to the commencement of the meeting, the ticket holder may either.
 - a. Request exchange tickets for an equivalent meeting by returning the tickets to SRC within 2 business days of the cancelled or rescheduled meeting, and SRC will, if possible provide the exchanged tickets (but does not guarantee that it will be able to do so), or
 - b. Return the tickets to SRC within 30 days of the cancelled meeting to obtain a refund of the price paid for the tickets (excluding any booking charges).
 - c. Carnival Function tickets are exempt from this refund policy.
- 1.4 SRC reserves the right to cancel, reschedule and/or vary advertised race meetings and races at any time.
- 1.5 Tickets may not be on sold or offered for resale at a premium (including via online auction sites) or, without the written consent of the SRC, used from commercial, advertising, or promotional purposes in connection with other goods and services. Breach of this condition may result in the cancellation of the ticket and refusal of entry to the ticketholder.

2 EVENT TICKETING

Event tickets to be sold subject to the following conditions:

- No refund or exchange on any ticket.
- 2.2 The SRC reserve the right to cancel, reschedule and. Or vary advertised function and events at any time.
- 2.3 Tickets may not be sold or offered for resale at a premium (including via online auction sites) or, without the written permissions of the SRC, used for commercial, advertising, or promotional purposes on connection with other goods or services. Breach of this conditions may result in cancellation of the ticket and refusal of entry to the ticket holder.



3 DRESS CODE

3.1 We kindly ask that you adhere to our dress code which is in place to maintain the sense of occasion that makes a race day so special. Those not adhering to the dress code in the Members and Function spaces will be denied entry. Please refer to our dress code on our website.

4 ENTRY

By purchasing tickets, you are deemed to have accepted the following terms and conditions of entry.

- 4.1 Visitors entering the racecourse do so at their own risk. The SRC accepts no responsibility for injury to any person (including injury resulting in death), or damage to or loss of property of any visitor occurring on or about the racecourse.
- 4.2 The SRC reserves the right to refuse entry to, or remove from, the racecourse, any person who in the opinion of any SRC representative is:
 - a. Behaving, or is in a group of persons behaving, in a manner which is causing or is likely to cause disruption, nuisance or offence to other patrons, harms to persons or horses, or damage to property.
 - b. Is inappropriately dressed, or in fancy dress.
 - c. Fails to comply with any of these conditions of entry to the racecourse.
- 4.3 Persons who appear to be intoxicated or under the influence of drugs upon arrival or whose presence at the racecourse could be detrimental to the good conduct or racing will be refused entry.
- 4.4 The following are not permitted to be bought onto the racecourse:
 - a. Beach umbrella's, tables or pop up marguess
 - b. Alcohol or illegal substances
 - c. Knives, firearms, or other items that could potentially be used as a weapon.
 - d. Flares, fireworks, plastic horns, musical instruments, whistles, laser lights, and other items which may have the potential to cause alarm and/ or harm to animals t other patrons.
 - e. Any other item deemed by any SRC representative to have the potential to disrupt the orderly conduct of the race meeting and/ or cause breach of SRC's duty of care to all persons entering the racecourse.



Bag searched may be undertaken to ensure compliance with these conditions.

- 4.5 Patrons may not bring animals onto the racetrack (other than a companion animal in the company of a sight-or hearing-impaired person)
- 4.6 Patrons are not permitted to trespass onto the racetrack at any time and will be prosecuted if they do so.
- 4.7 Patrons may be requested to provide proof of identity and/ or age at any time.
- 4.8 Security cameras operate in this venue, patrons may be filmed.
- 4.9 For the safety of patrons and horses, no unlicenced person is allowed access to any horse movement areas without the direct approval and/ or supervision of their Licenced trainer, and/ or Racing NSW personnel, and/ or SRC employee. These areas include, but are not limited to:
 - a. Race day tie-up stalls.
 - b. Float car park.
 - c. Mounting yard
 - d. Racetrack.

5 LIQUOR ACT 2007

- 5.1 This venue has the right to refuse entry to any person or withdraw any person's permission to remain on the premises at any time.
- 5.2 Under the Liquor Act 2007, alcohol must not be roved from the racecourse.
- 5.3 It is an offence to sell or supply to or obtain liquor on behalf of persons under the age of 18.
- 5.4 Patrons observed consuming alcohol on approach to the venue will be denied entry.
- 5.5 For the purpose of definition of a responsible adult, a person who is of or above the age of 18 and who is, in relation to the minor, a responsible adult for the purpose of the Liquor Act 2007:
 - a. A parent, stepparent, or guardian of the minor
 - b. The minor's spouse or any person who, although not legally married to the minor, ordinarily lives with the minor as the minor's spouse on a permanent and domestic basis and is 25 years and older.



6 MINORS

6.1 Persons under the ages of 18 are not permitted entry to the racecourse unless accompanied by a parent or guardian and must remain in the company of the adult at all times. A simple definition of parent or guardian is 'a person over the age of 18 who is a parent or guardian of the minor, must be old enough to be that parent'. The parent or guardian is responsible for the care, conduct and supervision of the minor, and for any acts or omissions of that minor.

7 CAR PARKS AND POSSESSIONS

- 7.1 Entry into and parking and leaving of vehicles in the car parks at the racecourse is at the risk of the driver/ rider and passengers.
- 7.2 Whilst at the racecourse patrons are responsible for their own property. Patrons must not leave bags or possessions unattended at any time and should ensure all valuables are removed from vehicles.

8 GAMBLING AND WAGERING

- 8.1 Patrons under the age of 18 are not permitted to gamble and if caught will be prosecuted.
- 8.2 It is an offence to transmit from this racecourse the betting odds being offered by the bookmakers on any horse.

9 RACING NSW

- 9.1 All patrons attending racecourses in NSW are subject to the Australian Rules of Racing (including the NSW local rules of Racing) administered by Racing NSW
- 9.2 Attendees must comply with all rules and regulations set forth by Racing NSW
- 9.3 Any breaches of these regulations may result in eviction from the premises.

10 PHOTOGRAPHY, FILM AND RECORDING

- 10.1 By attending an event (Race meeting or otherwise), each patron acknowledges that they may be photographed, filmed and/or recorded in any way and:
 - a. Consents to being photographed, filmed and/or recorded by or on behalf of SRC for SRC's advertising and promotional purposes (including, without limitation for promotion of SRC race days or events)



- b. If the patron is an owner of any horse at the racecourse or whose image is displayed at the racecourse, consent to their horse/s being photographed, filmed and/or recorded by or on behalf of SRC and for SRC to use and reproduce such photographs, films, and recordings (including colours worn by relevant jockeys) for SRC's advertising and promotional purposes.
- c. Assigns any and all intellectual property rights they may have in any such photographs, films and recordings to SRC, and agrees the SRC and its successors and assigns will own all right, title and interest in such photographs, films and recordings and may exercise all intellectual property rights existing in or in relation to any photographs, films and recordings throughout the world in perpetuity, free from any liens, claims, encumbrances or rights of termination by the patron or anyone else.
- d. Waives absolutely and irrevocably any moral rights they may gave in or in relation to any of the photographs, films and recordings referred to in this condition 10.2.
- 10.2 Patrons must not, unless authorised by SRC in writing and, if authorised, only on conditions determined by SRC, take photographs, or make any films, video, digital or sound recordings (including by way of handheld communication devices) within the racecourse for commercial purposes.

11 DISTRIBUTION OF GOODS OR MATERIAL

11.1 Patrons must not attempt to sell or distribute any goods or advertising materials or similar to persons attending or exiting the racecourse without the written consent of SRC.

12 PRIVACY POLICY

- 12.1 The SRC are committed to ensuring the privacy of any personal information provided to us. The following statement covers our general policy for the protection of your privacy:

 We are bound by the National Privacy Principles which form part of the Privacy Act 1988. At your request we can provide you with additional information about the way our organisation manages the personal information it holds.
- 12.2 We will not disclose your personal information to any other organisation or person unless there is a legal requirement to do so.



13 PAYMENT POLICY

- 13.1 All prices are in Australian dollars and are exclusive of GST.
- 13.2 Payment is required in advance for all bookings.
- 13.3 We accept credit card payments online via our website and/or booking platform partner and provides security for sensitive data such as credit cards.
- 13.4 We accept payment via credit cards such as Mastercard and Visa. American Express may not be valid on some platforms.

14 BREACH OF CONDITIONS OF ENTRY

- 14.1 If you breach any of the above conditions, or the SRC (with reasonable cause) directs you, you may without limitation:
 - a. Be refused entry to the racecourse.
 - b. Be evicted from the racecourse.
 - c. Be required to surrender articles in your possession.
 - d. Have your ticket confiscated or cancelled; and/ or
 - e. Be reported to an appropriate law enforcement body.

15 NON-SMOKING VENUE

15.1 Patrons must adhere strictly to SRC's directions and signage prohibiting smoking in all smoke free areas of the racecourse as required by the Smoke Free Environment Act 2000 (NSW) (Act). Its is an offence under the Act to smoke in areas designated by the Act as a "smoke free zone'. Designated Smoking Areas are clearly signed and available away from spectator areas.
